- ▶ Please return contract with payment NO LATER than January 20, 2012.
- ▶ Dealers will provide their own table covers to floor. Nothing may protrude from tables and items for sale may not be on the floor, under, or in front of the tables. Shelving or displays may not exceed three feet above the table top.
- ▶ Tables are non-transferable. No dealer may move, transfer, sell, or trade tables assigned nor use empty tables without permission.
- ▶ Set up time is 8:00 AM. Tables ready by 9:50 AM. No display shall be removed or packed prior to 3:00 PM. Complimentary cup of coffee and do-nut to dealer and one (1) helper. Please do not set up prior to check-in.
- ▶ Each dealer/vendor is responsible for collecting and paying the 6% state sales tax.
- ▶ Dealers **MUST** arrive by 9:15 AM or your table will be subject to forfeiture.
- ▶ No Refunds in the event of a hurricane or other natural disaster.
